

Johnson O'Malley Grant STANDARD OPERATING PROCEDURE

Tulalip – Marysville School District

Johnson O'Malley (JOM) funds are provided for Native students enrolled and attending full-time in the Marysville School Distrct. JOM funds are supplementary and are not intended to take the place of federal, state or local funds.

There are four quarters; students can receive up to \$500 per school year.

• REQUIREMENTS FOR SUBMITTING A JOM APPLICATION:

- 1. Completed JOM application with appropriate signatures.
- 2. Verification by the Marysville School District Indian Education Department or documentation of ethnicity by the proof of the enrollment or descendancy of the tribe (you can obtain this information from your tribe or the Bureau of Indian Affairs).
- 3. Skyward class schedule.
- 4. Invoice, order form, or official price listing of items requested.
- 5. If you are requesting reimbursement, you must submit original receipt.

• FINANCIAL SERVICES PROVIDED:

- 1. Shoe and clothing purchase orders: \$90.00 per quarter.
- 2. Physical Education.
- 3. Mathematics calculator.
- 4. Placement testing fees, such as: ACT, SAT, or COMPASS.
- 5. Music classes for choir and/or band rental fees.
- 6. Class fees such as: art, wood shop, home economics, science, etc.
- 7. Extracurricular activities, including ASB, field trips, workshops, clubs, and sports.
- 8. Credit retrieval: students must receive a passing grade in order to receive further credit retrieval funding.
- 9. Summer school.
- 10. Running Start.
- 11. Graduation supplies.
