The Tulalip Tribes of Washington ("Tribes") is soliciting qualified Engineering (Construction, Infrastructure) firms to submit Proposals including preliminary and final design, engineering, and construction documents for the pavement rehabilitation and safety improvements for the 81st Street NE project. Improvements include milling and resurfacing of the existing asphalt pavement to address rutting, cracking, and other distresses, which will provide a new fully paved two lane road. Additional improvements include revisions to the storm water conveyance system; illumination and signage; ADA accommodations; and reconstruction of the cul-de-sac roundabout at the end of 81st Street NE (Route # 1050/810-840).
