What is the Tulalip Child Support Program about?

Child support is something fairly new in Indian Country. Currently, there are only 14 Tribes in the United States that are operating their own child support program. In the last 6 years, those Tribal Child Support Programs have collected over 68 million dollars. 26 Tribes are in the start-up phase, which means they are creating a child support program unique to their Tribe. 19 of those Tribes anticipate opening their offices in 2008. Tulalip anticipates being able to take cases in early 2009.

FAQ

Please note these are generic questions people ask. Individual cases are unique. To get answers specific to your case, please contact Washington State Child Support or Tulalip Child Support Enforcement.

How is a child support case established? I never opened a case.

If you ever received Medical or State TANF or Tribal TANF, the case manager of that department automatically opens a child support case.

I am a Tribal Member, do I have to go through the state to request child support? No, Tribal members or parents of Tribal members can go to Tulalip Tribal Court to establish and enforce child support. Forms are available at Tulalip Tribal Court.

I want to establish a child support order, what do I do? What paperwork do I need?
