**Unlawful harassment** means a knowing and willful course of conduct directed at a specific person which seriously harms, annoys, or harasses, or is determined to such person and which serves no legitimate or lawful purpose. The course of conduct shall be such as would cause a reasonable person to suffer substantial emotional distress or would cause a reasonable person to fear for well-being of their family and shall actually cause the Petitioner substantial emotional distress or fear for the well-being of his or her family. "Course of conduct" means a pattern of conduct composed of a serious of acts over a period of time, however short, evidencing a continuity of purpose. "Course of conduct" includes, but is not limited to, in addition to any other form of communication the sending of an electronic communication.
