#### 1. Introduction

A Strategic Transportation Safety Plan (STSP) highlights the transportation safety needs in communities and recommends how to address them. This STSP is intended to identify where current safety issues exist and provide documentation of strategic and specific solutions to these safety issues. This plan has been established based on input and assistance from various departments within Tulalip Tribes and representatives from surrounding jurisdictions.

The Tulalip Tribes Reservation is located in Snohomish County, Washington with the Tribal headquarters located in the city of Tulalip, Washington.

The reservation utilizes Tribal roadways and roadways owned by Washington State Department of Transportation (WSDOT), Snohomish County, and City of Marysville as access to Tribal facilities, culturally sensitive lands, and business. It is therefore important to understand the existing safety measures and collision history of these roadways and determine strategies and solutions to improve safety along these roadways.

#### 2. VISION AND GOALS

The goal of this STSP is to evaluate and improve safety for all users of the transportation system in the Tribal area. The focus area for this plan is the concentrated area of the Tribal operations and where Tribal members live. Tulalip Tribes is committed to reducing roadway deaths to zero by 2045 through intelligent planning effort and roadway design activities. Continued practice and key actions to achieve this goal include:

- Integrating planning efforts with design and operations to implement appropriate safety improvement measures
- Implementing community education programs aimed at improving vehicle and pedestrian safety
- Incorporating design elements to roadways that encourage drivers to reduce speeds and create a safer environment for vulnerable roadway users

## 3. Process

This STSP was established through stakeholder participation and a collection of pertinent data from the Tribe and surrounding jurisdictions. Stakeholders are identified as a member of the STSP process because of their expertise and experience in local conditions, traffic engineering, safety, roadway design, traffic operations, or human factors within the Tribal area. A summary of the stakeholder meetings is below.

# 3.1. Kick-off/Stakeholder Meeting #1

The Kick-off/Stakeholder Meeting #1 held on September 17, 2024, included representatives from the Tribe, consultant team assisting the Tribe, and stakeholders. A representative from the following groups attended Stakeholder Meeting #1:

- Tulalip Tribes Roads and Transportation Group
- Tulalip Tribes Federal Corporation
- Tulalip Police Department



- Quil Ceda Village
- Snohomish County Traffic Operations
- City of Marysville Traffic Engineering
- Snohomish County Sheriff's Office
- Community Transit
- Parametrix

Additional groups were invited to the meeting but could not attend. During Meeting #1, collision data and planned and programmed projects were discussed. Pertinent information was generated and discussed by all parties in subsequent communications. Those communications are reflected in this STSP and the meeting minutes **Attachment A.** 

Based on stakeholders input and the finalized collision data analysis, recommendations to address the transportation safety concerns were established. These recommendations were reviewed by Tribal staff and incorporated into this plan.

#### 4. DATA REVIEW

Data from Snohomish County and WSDOT was obtained for the major roadways providing access to and utilized by the Tribe. Data was obtained for the period from January 1, 2020 to June 31, 2024, a period of 4.5 years. The collision data is provided in **Attachment B**.

The data along these corridors underwent analysis for overall trends. Detailed analysis was then conducted at the identified top collision locations, and at the additional intersections and segments identified in response to stakeholder concerns.

The data review focuses on collisions within the main area of the reservation. Notably, Interstate 5 (I-5) runs along the eastern edge of the reservation boundary and experiences heavy traffic with a high number of congestion related collisions. To ensure the analysis is not overshadowed by collisions related to I-5, the following collision locations were excluded from the review:

- I-5 Mainline
- I-5 On/Off Ramps
- I-5 Interchange Intersections

The key findings in the data include:

- The number of collisions that occur within the reservation is increasing each year
- Four fatal collisions:
  - One pedestrian, two fixed object, and one overturned vehicle.
- Top five primary collisions intersections:
  - Quil Ceda Boulevard at 88<sup>th</sup> Street NE: 51 collisions (1.35 per million entering vehicles [MEV])
  - 33<sup>rd</sup> Avenue NE at Marine Drive NE: 28 collisions (0.88 per MEV)
  - 31st Avenue NE / 64th Street NE at Marine Drive NE: 23 collisions (0.87 per MEV)
  - Quil Ceda Boulevard at 116<sup>th</sup> Steet NE: 18 collisions (0.67 per MEV)



- 27<sup>th</sup> Avenue NE at Marine Drive NE: 15 collisions (0.48 per MEV)
- Top primary collision segments:
  - Quil Ceda Boulevard just north of 31<sup>st</sup> Avenue NE (14 collisions)
  - Marine Drive NE between Meridian Avenue N and 2<sup>nd</sup> Avenue NE (12 collisions)

## 4.1. Collisions by year

There was a total of 516 collisions during the five-year study period. The collision data shows an increase in collisions from 2020 to 2023, with the largest increase occurring between 2020 and 2021. In 2023, the highest number of collisions accounted for 27% of all collisions during the study period. It is important to note that the collision data for 2024 only includes the months of January to June. However, with 65 collisions already recorded, it is projected that there will be a total of 130 collisions or more by the end of the year, similar to the number in 2023. The yearly collision data is shown **Table 1** and can be seen in **Figure 1**.

# 4.2. Severity

Collisions were broken down by severity and year. From 2020-2024, there was a total of four fatal collisions (1% of total), 14 suspected serious injury collisions (3% of total), 64 suspected minor injury collisions (12% of total), 74 possible injury collisions (14% of total), and 328 no apparent injury collisions (64% of total). The collision severity data is shown in **Table 2**.

The main contributing factors to vehicle collisions in the study area is distracted driving, followed by other/unknown causes and vehicles following too closely. The data shows distracted driving accounted for



94 collisions (22% of all collisions). Other/unknown contributing factors accounted for 65 collisions (15% of all collisions) and following too closely accounted for 58 collisions (14% of all collisions) in the study area.

During Stakeholder Meeting #1, it was identified that a fatality on Turk Road occurred on September 9<sup>th</sup>, 2022 that was not included in the data set. The incident report and crash details for this fatality was not provided and therefore excluded from the analysis.

#### 4.2.1. Fatal and Serious Injury Collisions




Figure 2: Severe Collisions by Year

Breaking down fatal and suspected serious injury data by year provides a clearer understanding of trends, helps identify patterns, and allows for more targeted interventions to enhance road safety. During the study period, there were a total of 18 fatal and suspected serious injury collisions within the reservation. The year 2021 had the largest total of fatal and serious injury collisions (five total), followed by 2020, 2022, and 2024, each with four collisions. It's important to note that the 2024 data is only available for the first half of the year; therefore, additional collisions may occur in the latter part of the year. Based on existing collision data available to date for 2024, if fatal and serious injury collisions continue at the same rate through the remainder of 2024, they would double that of 2021, the prior highest year. The fewest fatal and suspected serious injury collisions occurred in 2023, with only one, which was a suspected serious injury. The severe collision data is shown in **Table 3** and **Figure 2**.

#### 4.2.1.1. Fatal Collision Narrative

- The first fatal collision occurred in September 2020 on wet pavement at night with a southbound vehicle striking a pedestrian along 33rd Avenue NE. The pedestrian failed to give right of way to the vehicle while attempting to cross 33rd Avenue NE at a non-intersection approximately 180 feet south of 64th Street NE with no crosswalk with no streetlights. The southbound vehicle then struck the pedestrian, resulting in the fatality of the pedestrian.
- The second fatal collision occurred in September 2021 on dry pavement at night with two westbound vehicles along Marine Drive NE near 14<sup>th</sup> Avenue NE. This collision occurred when Vehicle 1 was rear-ended attempting to overtake and pass Vehicle 2. Vehicle 1 was then overturned, and the driver ejected from the vehicle, resulting in the fatality of the driver. It is unknown if restraints were used.
- The third fatal collision occurred in July 2022 on dry pavement during the day with a single northbound vehicle traveling on Marine Drive, approximately 150 feet south of 135<sup>th</sup> Place NW / Sunny Shores Road. This collision occurred when the driver was speeding and overcorrected, resulting in the vehicle going over the embankment, with no guardrail present, and striking a tree. The driver was ejected from the vehicle, resulting in the fatality of the driver. The driver was not utilizing any restraints.
- The fourth fatal collision occurred in March 2024 on dry pavement during the day with a single southbound vehicle traveling on 89th Drive NW approximately 375 feet south of Priest Point Drive NW. This collision occurred when the vehicle went over the embankment, with no guardrail present, striking a tree due to an unknown driver distraction. The driver was ejected from the vehicle, resulting in the fatality of the driver. It is unknown if restraints were used.




Figure 3: Fatal and Suspected Serious Injury Map

Figure 3 shows the location of the fatal and suspected serious injury collisions within the reservation.

#### 4.3. Vulnerable Road Users

Vulnerable Road User (VRU) collisions were broken down by year. There was a total of eight pedestrian and no pedalcyclist collisions between January 2020 – June 2024.

#### 4.3.1. Pedestrian Collision Narrative

The 2020 pedestrian collision was a fatality described above in Fatal Collision Narrative.

A total of five pedestrians were involved in four collisions in 2021: two suspected serious injury and two suspected minor injury.

One of the suspected serious injury collisions occurred in dark conditions with no streetlights when
a speeding vehicle proceeded to strike a fallen tree and then a construction worker in the roadway
approximately 4300 feet south of Water Works Road.



- One suspected serious injury collision occurred under dark conditions with streetlights on when a single vehicle struck three pedestrians who were crossing at an intersection against the signal at Water Works Road and Marine Drive.
- One suspected minor injury collision occurred in dark conditions with no streetlights when a vehicle struck a pedestrian walking in the roadway with traffic along 128<sup>th</sup> Street NE approximately 200 feet east of 26<sup>th</sup> Avenue NE.
- One suspected minor injury collision occurred under daylight conditions when a right turning vehicle did not grant right-of-way (ROW) to pedestrian at 27<sup>th</sup> Avenue and 99<sup>th</sup> Place NE.

A total of two pedestrians involved collisions occurred in 2023: one possible injury and one suspected minor injury.

- The possible injury occurred at night with streetlights on along 99<sup>th</sup> Avenue NE, approximately 500 feet west of Quil Ceda Boulevard, when a distracted driver struck a pedestrian attempting to cross the roadway with no cross walk.
- The suspected minor injury also occurred at night with streetlights on along Mission Beach Road, approximately 725 feet south of 64<sup>th</sup> Street NW, when a distracted driver struck a physically impaired pedestrian in the roadway.




Figure 4: Vulnerable Road User Collision Map

Figure 4 shows the location of the pedestrian collisions from January 2020 – June 2024 within the reservation.

#### 4.4. Manner of Collision

The manner of collision is broken down by year for both intersection and non-intersection related collisions. From 2020-2024, the top manner of collision was angle (128 collisions), rear-end (101 collisions), hit fixed object (87 collisions), sideswipe same direction (64 collisions), and left turn (39 collisions). Of the angle collisions, 98 collisions (77% of 128 collisions) were intersection related. Of the rear-end collisions, 51 collisions (51% of 101 collisions) were not intersection related. The manner of collision data is shown in **Table 5**.




Figure 5: Primary Cause of Collisions

Collisions were classified by contributing circumstances. From 2020-2024, there were a total of 92 collisions (18% of total) caused by failure to grant ROW, 64 collisions (12% of total) caused by improper turn/merge, 50 collisions (10% of total) caused by an unknown distraction, 49 collisions (10% of total) caused by following too closely, and 29 collisions (6% of total) caused by a driver under the influence of alcohol. Over 50% of the crashes occurred at five locations. A detailed analysis of the top five locations is summarized in **Section 4.5** with recommendations to address these crash types. The primary cause of collisions is shown in **Figure 5**.

# 4.5. Primary Collision Intersections

There was a total of 64 intersections with at least one collision during the study period, with a total of 258 intersection related collisions. The predominant collision type was at-angle collisions (96 collisions) followed by rear-end (44 collisions), sideswipe (39 collisions), and opposite direction (38 collisions).

The top five intersection collision locations are:

- Quil Ceda Boulevard at 88th Street NE
- 33rd Avenue NE at Marine Drive NE
- 31st Avenue NE / 64th Street NE at Marine Drive NE
- Quil Ceda Boulevard at 116th Street NE
- 27th Avenue NE at Marine Drive NE.




Figure 6: Primary Collision Intersections

These five locations accounted for 52% of all intersection collisions that occurred on the Tulalip Tribes Reservation. The primary collision intersections are presented in **Table 6** for each year showing collision frequency and collision rate. The primary collision intersections are shown in **Figure 6**.

## 4.5.1. Quil Ceda Boulevard at 88th Street NE

Quil Ceda Boulevard at 88th Street NE was identified as the location with highest collision frequency, with 51 collisions recorded during the study period, averaging 11.33 collisions per year. The most common types of collisions at this location were sideswipe same direction and angle collisions. These incidents were mainly caused by improper turns or merges between the westbound right and southbound left movements. There were no fatal or suspected serious injury collisions. The intersection should be reviewed for improved channelization to provide better separation between the outside westbound right and inside southbound left movement. This intersection is being evaluated as part of the 88th Street Interchanges to be a future roundabout. The collision manner and severity for Quil Ceda Boulevard at 88th Street NE is shown in **Table 7**.

#### 4.5.2. 33rd Avenue NE at Marine Drive NE

33rd Avenue NE at Marine Drive NE is the second top collision location, with 28 collisions recorded during the study period, averaging 6.22 collisions per year. The two most common types of collisions at this location were left turn and rear-end/angle collisions. The primary cause of the left turn collision was the left-turning vehicle's failure to yield to the opposing vehicle. Rear-end and angle collisions were mainly caused by improper turns, merges, or vehicles following too closely. There were no fatal or suspected serious injury collisions. This intersection is being evaluated as part of the 88th Street Interchanges to be a future roundabout. The collision manner and severity for 33rd Avenue NE at Marine Drive NE is shown in **Table 8**.

# 4.5.3. 31st Avenue NE / 64th Street NE at Marine Drive NE

31st Avenue NE / 64th Street NE at Marine Drive NE is the third top collision location, with 23 collisions recorded during the study period, averaging 5.11 collisions per year. The two most common types of collisions at this location were angle and sideswipe same direction collisions. The primary causes for both collision types were improper turns or merges and failure to yield the ROW, which are common collision types at roundabouts. It is important to note that the high number of angle collisions is inconsistent with typical roundabout collisions. Additional follow up is being conducted with WSDOT. The roundabout should be reviewed for improved signage and striping based upon latest roundabout best practices. There were no fatal or suspected serious injury collisions. The collision manner and severity for 31st Avenue NE / 64th Street NE at Marine Drive NE is shown in **Table 9**.

## 4.5.4. Quil Ceda Boulevard at 116th Street NE

Quil Ceda Boulevard at 116<sup>th</sup> Street NE is the fourth top collision location, with 18 collisions recorded during the study period, averaging 4.00 collisions per year. The two most common types of collisions at this location were sideswipe same direction and rear-end/angle collisions. Sideswipe collisions were primarily caused by improper turns or merges involving dual left turns for the westbound and southbound directions, and dual right turns for the northbound direction. The westbound left turn sideswipes could be caused by the driver on the inside lane attempting to merge to access the gas station located in the southwest corner of the intersection. The primary cause of angle collisions was failure to yield the ROW, while rear-end collisions were often due to following too closely or distracted driving. There were no fatal or suspected serious injury collisions. The intersection should be reviewed for improved phasing/signal timing and skip lines for southbound lefts and westbound rights. The collision manner and severity for Quil Ceda Boulevard at 116<sup>th</sup> Street NE is shown in **Table 10**.

### 4.5.5. 27th Avenue NE at Marine Drive NE

27<sup>th</sup> Avenue NE at Marine Drive NE is the fifth top collision location, with 15 collisions recorded during the study period, averaging 3.33 collisions per year. The two most common types of collisions at this location were rear-end and angle collisions. Rear-end collisions were primarily caused by vehicles following too closely in the southbound direction, while angle collisions were mainly due to drivers under the influence of drugs or alcohol. There were no fatal or suspected serious injury collisions. The intersection should be reviewed for appropriate all red and yellow change intervals in addition to an advanced intersection warning system. For the angle collisions, primarily due to drivers under the influence of drugs or alcohol, increasing enforcement in the area should be considered. The collision manner and severity for 27<sup>th</sup> Avenue NE at Marine Drive NE is shown in **Table 11**.

## 4.6. Primary Collision Segments

A total of 258 collisions occurred on street segments during the study period. There were a total of 22 collisions, 8.5% of segment collisions, with the primary cause of the driver being under the influence of alcohol or drugs. Most segment collisions occurred in close proximity to the primary intersection collision locations. This pattern suggests a strong correlation between the high-traffic intersections and the nearby street segments, where the flow of vehicles entering and exiting these intersections likely contributes to the increased frequency of collisions.

Two key segments were identified as the primary collision areas: Marine Drive, with 79 collisions, and Quil Ceda Boulevard/34th Street, with 49 collisions. The most common types of collisions on these segments were angle, rear-end, and sideswipe collisions, primarily caused by failure to yield the ROW and following too closely.

#### 4.6.1. Detailed Primary Segment Locations




Figure 7: Primary Collision Segment Clusters

The two collision segments described above are long length segments. However, it is equally important to identify smaller segments with a higher volume of collisions. **Figure 7** illustrates the specific smaller segments that have been identified. These clusters provide a more detailed understanding of the areas with the most frequent accidents.

Four primary cluster locations shown in Figure 7 are listed below.

- A cluster of 14 segment collisions occurred along Quil Ceda Boulevard just north of 31<sup>st</sup> Avenue NE; 2 collisions were reported as possible injury with the remaining as no apparent injury. Along the segment, six collisions were reported as driveway related with the primary cause being failure to grant ROW. It is recommended that access spacing for new developments be reviewed.
- 2. A cluster of 12 segment collisions occurred along Marine Drive NE between Meridian Avenue N and 2<sup>nd</sup> Avenue NE; one collision was reported as suspected minor injury, two collisions were reported as possible injury, and nine collisions were reported as no apparent injury. The major driveways along this segment are to grocery stores were 50% (6) of the collisions occurred caused by drivers failing to grant ROW while entering the roadway.
- 3. A cluster of six segment collisions occurred near the intersection of Quil Ceda Boulevard and 105<sup>th</sup> Street NE. No injuries were reported with four of the collisions were classified as same direction collision types. Lighting is not an identified issue as 50% (3) collisions occurred during the daylight and 50% (3) occurred during the night with streetlights on. One of the collisions involved a driver under the influence striking a metal signpost.
- 4. A cluster of seven segment collisions occurred near the intersection of 34<sup>th</sup> Avenue NE and 136<sup>th</sup> Street NE; four collisions were reported as no apparent injury, one possible injury, one suspected minor injury, and one suspected serious injury. Two collisions were a result of drivers under the influence: one head on collision (suspected serious injury) and one guardrail (no apparent injury).

The primary focus for addressing the collisions on these segments is through planned intersection improvements along Marine Drive and Quil Ceda Boulevard. These improvements identified for the primary



collision intersections will address locations along the primary segments. Additionally, implementing education and enforcement measures provides further mitigation for collisions.

#### 4.7. Stakeholder Areas of Concern

#### 4.7.1. Tulalip Bay

Tulalip Bay is a primary residential and commercial center on the reservation with the primary north/south roadway of Marine Drive. Marine Drive was analyzed from Arcadia Road to 56<sup>th</sup> Street NW. This segment of Marine Drive includes Walter Moses Jr Drive / Larry Price Loop Road at Marine Drive and Edward Beatty Road / Lloyd Hatch Sr Drive at Marine Drive, both presented as areas of concerns by a stakeholder.

There was a total of 36 collisions along Marine Drive from Arcadia Road to 56<sup>th</sup> Street NW; 21 collisions (58% of the total) were not intersection related. The collisions were categorized by collision manner and injury severity. There were four suspected serious injury collisions; two were pedestrian collisions (the only two pedestrian collisions on the segment), one hit fixed object collision, and one left turn collision. The collision data for Marine Drive in Tulalip Bay is shown in **Table 12**.

During Stakeholder Meeting #1, speeding and pedestrian safety emerged as key concerns on the Marine Drive Road segment. Two collisions were attributed to speeding, one of which involved a pedestrian.

- The pedestrian related collision occurred in dark conditions without streetlights, as a speeding vehicle struck a fallen tree and a construction worker approximately 4300 feet south of Water Works Road. The severity of the collision was suspected to result in serious injury.
- The other collision related to speeding took place in overcast wet conditions, where a speeding vehicle rear-ended another vehicle and crashed into an earth bank at the intersection of Marine Drive and 42nd Drive NW. No apparent injuries were reported in this collision.



Marine Drive in Tulalip Bay should be considered for traffic calming countermeasures and improved lighting along the corridor. Additionally, a road safety audit (RSA) within the corridor was performed at Hermosa Point in Spring 2024. This RSA recommended Intersection Control Evaluation (ICE) studies be conducted at the following intersections along Marine Drive:

- Marine Drive at Hermosa Beach Road
- Marine Drive at Beautiful Point Road
- Marine Drive at 42<sup>nd</sup> Drive NW

#### 4.7.2. 140th Street at 23rd Avenue

The intersection of 140th Street and 23rd Avenue is an alternate route used by vehicles travelling locally to the commercial area of Smokey Point, located north of the reservation. Two collisions occurred at this intersection, both of which were angle collisions. One resulted in a possible injury, while the other was no apparent injury. It is important to note that the reservation boundary runs through the center line of 140th Street, so there may be additional collisions not included in the provided data. This location is being monitored by Snohomish County.

During Stakeholder Meeting #1, concerns were raised about the safety of 140<sup>th</sup> Street for vulnerable road users. There was a total of 19 collisions for eastbound and westbound vehicles along 140th Street, with 15 of them (79% of the total) not being intersection related. No collisions involving pedestrians or cyclists were reported on 140th Street.

#### 4.7.3. 27th Avenue NE at 116th Street NE

The intersection of 27<sup>th</sup> Avenue NE and 116<sup>th</sup> Street NE serves local residential areas and the nearby Washington State Patrol. Stakeholder Meeting #1 identified this intersection as a primary detour for vehicles when there is heavy congestion on the nearby I-5. There was a total of five collisions at this intersection. These included two collisions in the roadway ditch, two collisions with fixed objects, and one rear-end collision. One of the rear-end collisions resulted in a suspected serious injury. Disregard for traffic signs was identified as an issue at this intersection, with one collision attributed to this behavior and no apparent injuries reported.

Stakeholder Meeting #1 also identified 116<sup>th</sup> Street west of 27<sup>th</sup> Avenue NE as a segment of concern. There was a total of six collisions on this stretch of road, including five in the roadway ditch and one sideswipe collision in the same direction. One collision attributed to speeding occurred, resulting in no apparent injuries. There were no fatal or serious injury collisions on 116<sup>th</sup> Street west of 27<sup>th</sup> Avenue NE. This intersection should be considered for an ICE.



#### 5. SUMMARY

There was a total of 516 collisions on Snohomish County, WSDOT and Tribal roadways over a 4.5-year study period. In 2023, the highest number of collisions accounted for 27% of all collisions during the study period. There were four fatalities and 14 suspected serious injury collisions. There was a total of eight pedestrians and no pedalcyclist collisions between January 2020 – June 2024.

From 2020-2024, the top manner of collisions was angle (128 collisions), rear-end (101 collisions), hit fixed object (87 collisions), sideswipe same direction (64 collisions), and left turn (39 collisions). There was a total of 92 collisions (18% of total) caused by failure to grant ROW, 64 collisions (12% of total) caused by improper turn/merge, 50 collisions (10% of total) caused by an unknown distraction, 49 collisions (10% of total) caused by following too closely, and 29 collisions (6% of total) caused by a driver under the influence of alcohol.

There was a total of 64 intersections with at least one collision during the study period, with a total of 258 intersection related collisions. The top five intersection collision locations are Quil Ceda Boulevard at 88th Street NE, 33rd Avenue NE at Marine Drive NE, 31st Avenue NE / 64th Street NE at Marine Drive NE, Quil Ceda Boulevard at 116th Street NE, and 27th Avenue NE at Marine Drive NE. These five locations accounted for 52% of all intersection collisions that occurred on the reservation.

A total of 258 collisions occurred on street segments during the study period. There was a total of 22 collisions, 8.5% of segment collisions. with the primary cause of the driver being under the influence of alcohol or drugs.

# **5.1.** Implemented Projects

Throughout the study area, several improvement projects have been implemented that are anticipated to reduce the frequency of collisions. These locations projects should be monitored to evaluate if the improvement projects have been successful in reducing collisions.

- 31st Avenue NE / 64th Street NE at Marine Drive NE converted to a roundabout.
- I-5/116th Street Interchange reconstructed as a Single Point Urban Interchange



## 5.2. Planned Projects

Stakeholders identified planned projects intended to improve road safety. Projects that have a direct impact on the study area are listed below:

- Quil Ceda Boulevard at 88<sup>th</sup> Street NE to be converted to a roundabout by 2029
- I-5 SB and NB Ramps at 88th Street NE intersections to be converted to a roundabout. By 2029
- 27<sup>th</sup> Avenue NE at 88<sup>th</sup> Street NE intersection improvements expected by 2040.
- 33<sup>rd</sup> Avenue NE at Marine Drive NE converted to a roundabout by 2029
- I-5 SB and NB Ramps at Marine Drive NE intersections to be converted to a roundabout by 2029
- Marine Drive at Hermosa Beach Road to be converted to a roundabout by 2029
- Marine Drive at 42<sup>nd</sup> Drive NW Coy (Coy Street) to be converted to a roundabout by 2030 Marine Drive signing improvements and access management at Beautiful Point Road/42<sup>nd</sup> Drive NW By 2026
- Marine Drive constructing 1.8 miles of pedestrian improvement to complete missing link by 2040.
- Meridian Avenue N constructing 1.1 miles of pedestrian improvements to complete missing link by 2040.
- Turk Drive Multi Modal Safety Improvements near Water Works Road by 2035.

Tulalip Tribes intends to complete all of these projects over the next 20 years, in line with the commitment to reduce roadway fatalities to zero over the same period. Furthermore, the following projects were identified as the highest priority projects, which the Tribe intends to complete within the next five to 10 years:

These projects were chosen as the highest priority due to the number of crashes that have occurred along this stretch of Marine Drive, the identification of a nearby segment of Marine Drive as one of the highest-risk segments within the reservation, and the identification of these intersections and the surrounding roadway network as the top safety concern for stakeholders.

# 5.3. Policy

The following transportation policy documents from the State, Snohomish County and Tulalip Tribes were reviewed:

- The Tulalip Tribes Transportation Improvement Plan (TIP) 2022 through 2026
- Snohomish County Transportation Element
- Washington State Strategic Highway Safety Plan 2024

The County and Tribal planning documents primarily align with the WSDOT 2024 Target Zero Plan. WSDOT 2024 Target Zero Plan will help the community eliminate traffic deaths and serious injury collisions while increasing safety and mobility for all. The policies in the plan play a role in increasing positive traffic safety behaviors. Policies in the plan include education and outreach, enforcement, engineering, evaluation, emergency medical services, and leadership.



#### 5.4. Recommendations

The Washington SHSP identifies four categories, containing a total of 11 emphasis areas, to focus on reducing traffic fatalities and serious injuries throughout the state, while addressing multiple types of safety strategies:

- Impairment
- Speeding and Speed Management
- Distraction
- Unrestrained Occupants
- Lane Departure
- Intersections
- Young Drivers
- Older Drivers
- Active Transportation Users
- Motorcyclists
- Heavy Vehicles

Improvements for the study area in alignment with the Washington SHSP and the planned improvement projects.

### 5.4.1. Policy Changes

It is recommended that Tulalip Tribe partner with regional agencies to implement educational and outreach programs to provide road users information to make good choices, such as driving unimpaired, wearing a seat belt, and avoiding distractions.

- Driver education to increase understanding of hazard perception and separation needed to help reduce collisions caused by vehicles following too closely.
- Pedestrian education about the risk of distracted walking to reduce the number of pedestrian collisions with vehicles.
- Work with the Tribal Government and casino resort management to involve them in the driver and pedestrian education campaigns.
- Work with Marysville School District to identify potential champion for pedestrian safety program.
  - Collaborate with Marysville School District to plan and implement a Safe Routes to Schools (SR2S) program. A SR2S program would include the following elements:
    - Education of students on safe walking and bicycling skills.
    - Encouragement of students to walk or bike to school.
    - Engineering design of roads and intersections to appeal to walking and bicycling.
    - Evaluation of effectiveness of steps taken in SR2S.



#### 5.4.2. Engineering

Design roads and roadsides using practical solutions to reduce collisions, or to reduce the severity of collisions if they do occur. Engineering recommendations are summarized in **Table 13** and shown in **Figure 8**. Project costs can be classified into three categories: Low (less than \$150k), Moderate (\$150k to \$1,000,000), and High (greater than \$1,000,000).

#### 5.4.3. Enforcement and Emergency Response

Use data-driven analysis to help law enforcement officers pinpoint and address locations with a high number of behavior-driven fatal and serious-injury collisions, such as those attributable to speeding and impairment.

- Partner with Tulalip Tribes Police Department to enhance coordination with Snohomish County Sheriff's Office Target Zero initiative.
- Coordinate with local law enforcement and engineering staff to monitor speeds at newly improved roadway segments and intersections, to address concerns that speeds will increase as roadway improvements are implemented.
- Collaborate with Snohomish County to implement traffic calming measures along Marine Drive.
- Allocate additional resources to Tulalip Tribes Police Department Traffic Enforcement Pilot Program that emphasizes speed enforcement, driving under the influence (DUI) investigation, and collision investigation.
