**Notice of Petition for Forfeiture and Summons by Publication**

The Tulalip Tribes Office of Reservation Attorney gives notice that the property listed below was seized for forfeiture for violation of Tribal Law. Laws and procedures applicable to the forfeiture process can be found in Tulalip Tribal Code (TTC) Chapters 2.10 and 2.15. **TO FILE A CLAIM:** If you are an owner or claimant, you may contest the forfeiture of the property listed below by filing an answer with the Tribal Court no later than 30 days after the date of final publication of this notice. You must serve a copy of your answer on the Tribal Prosecutor. If a verified answer is filed with the Court within 30 days, a forfeiture hearing will be set within 60 days of the date the answer is filed. You may request a copy of the summons, petition, and evidence in your case from the Tribal Prosecutor.
