FISH - (2) positions expiring - (3) year terms. <u>Gerald (Gerble) Fryberg Jr.</u> Qualifications: Eighteen (18) years of age or older. Have a minimum of five (5) years experience as a commercial fisherman. Be of good character.	<u>Harold Joseph III</u>
GAMING - (2) positions expiring - (3) year terms. <u>John Campbell</u> Qualifications: Twenty-one (21) years of age or older. ***Additional TGA background check fee required to run for this position with TGA Office.***	<u>Darcy Grant</u>
HUNTING - (2) positions expiring - (3) year terms. <u>Dylan Houle</u> Qualifications: Be eighteen (18) years of age or older.	<u>Flabio (Rusty) Loera</u>
PLANNING - (2) positions expirings-(3) year terms. <u>Curtis Enick</u> Qualifications: Eighteen (18) years of age or older. Not employed by the Tulalip Planning Department.	<u>Samantha Wilder</u>
POLICE ADVISORY BOARD - (2) positions expiring - (2) year term. <u>Amanda Shelton</u> Qualifications: Eighteen (18) years of age or older. Not employed by the Tulalip Police Department. Currently reside on the Tulalip Reservation, employed, or operate a business on the reservation. Have never been convicted of a felony or serious tribal crime (Class E or F).	<u>Vacancy</u>
TERO - (2) positions expiring - (3) year terms. <u>John Davis</u> Qualifications: Eighteen (18) years of age or older.	<u>Heidi Zackuse</u>
VETERANS - (1) term for Veteran and (1) term non-veteran expiring, with (3) year terms. <u>Bradley (Tony) Gobin—Veteran</u> Qualifications: Be eighteen (18) years of age or older. (1) position must be a veteran.	<u>Angela Tait—Non Veteran.</u>
All Commission positions must be a Tulalip Tribal Member and no person may be a candidate if he/she have been found of a felony, or a misdemeanor involving controlled substance or dishonesty in any Indian, State, or Federal court within three (3) years prior to the election. Candidates may run for more than one commission but can only hold one seat on a paid commission.

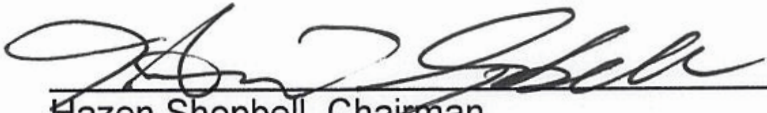
- * Candidates original signed petition
